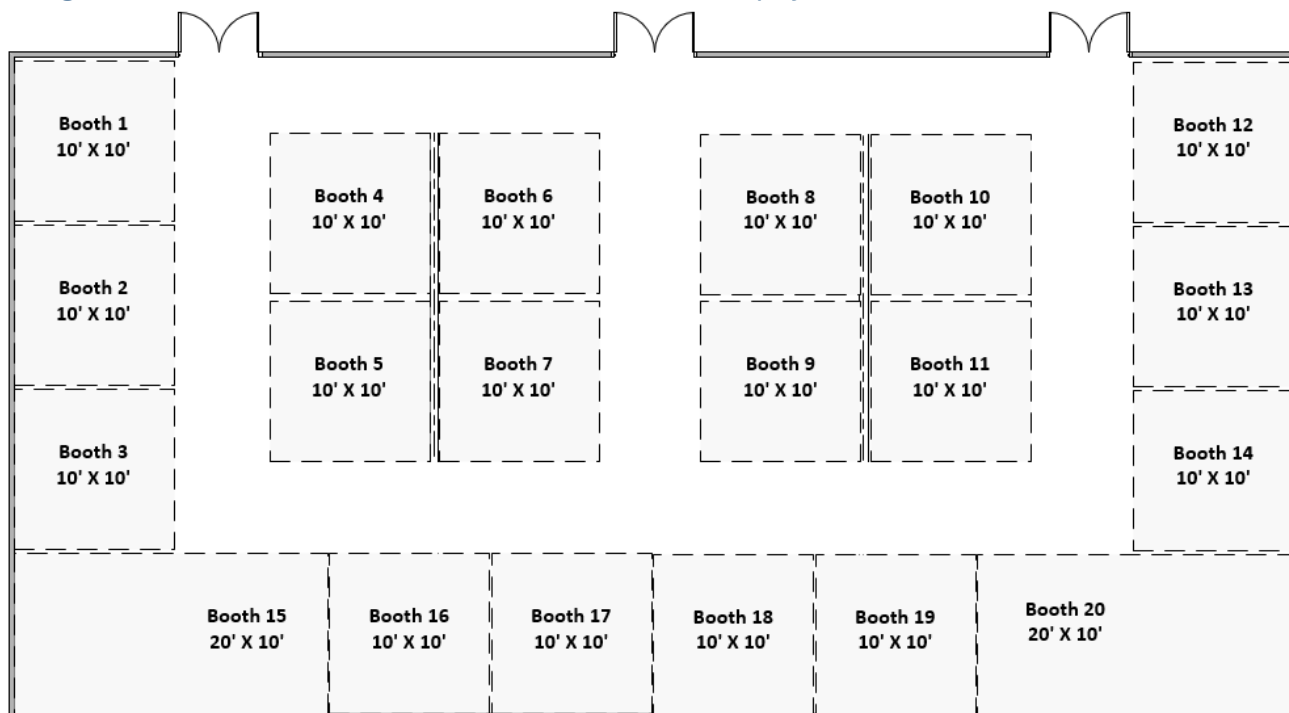

EXHIBITION TERMS & CONDITIONS

HTRI is organizing an exhibition of products and services of interest to the heat transfer industry (the “Exhibition”). The following terms and conditions apply to your participation in the Exhibition.

1. **Exhibit Fee.** The standard package fee is USD\$3,000 for members (\$4,500 for non-members); additional fees apply for upgrades and/or add-ons. A completed form and payment must be received before an Exhibition space is reserved.
2. **Exhibit Space.** Exhibit space includes
 - One 10’ x 10’ display space with 6’ table and two chairs in the Springwoods I - III meeting space of the event venue
 - Two complimentary two-day exhibitor registrations, including
 - a. Monday evening Welcome Reception
 - b. breakfasts, breaks, and lunches on Tuesday and Wednesday
 - Identification sign with company name and logo
 - Company logo and description posted on event page, conference app, and event promotions
 Exhibit space does not include shipping, labor, installation, or dismantling. Once HTRI receives the completed Exhibitor Registration Form, all registered exhibitors will receive a complete list of audio-visual equipment available through our preferred audio-visual provider, Chase Productions. Exhibitor is responsible for all expenses and fees associated with these services and equipment.
3. **Cancellation by Exhibitor.** All cancellations must be received by **June 30, 2026** to receive a 75% refund (a 25% space fee will be charged). Cancellations received **after June 30, 2026** are not eligible for a refund. In the event that payment has not been made at time of cancellation, you will be invoiced for the balance due.
4. **Cancellation or Postponement by HTRI.** On rare occasions, HTRI may need to cancel or postpone an event. If this occurs, you may choose one of the following options:
 - Receive a full refund of the exhibit fee.
 - Apply exhibit fee toward another HTRI event (within next 12 months).
 - Carry exhibit fee forward to rescheduled event (if the event is postponed).
5. **Security.** HTRI does not provide security in the meeting and exhibit space. All property left in the meeting or exhibit space is at the sole risk of the owner.
6. **Hotel and Vendor Property.** For the protection of the hotel’s furniture and building, nothing should be nailed, screwed, or otherwise attached to the columns, walls, floors, furniture, or any other parts of the building. Exhibitor is responsible for any damage to hotel or third-party vendor property resulting from its misuse of such property.
7. **Damage Waiver.** HTRI will not be responsible to you for any damage or claim of any type with respect to your participation in the Exhibition. You hereby indemnify and hold harmless HTRI from any such damage or claim with respect to your participation in the Exhibition.
8. **Photography.** All forms of photography, video, and audio recordings are prohibited without prior consent from HTRI. We frequently record and photograph events for use in HTRI products and services, for quality assurance, and for historical and promotional purposes. Additionally, events may be simulcast to other locations via a live video or audio feed. By signing the registration form, you acknowledge and agree that your image and/or voice may be used by HTRI for these purposes.
